## **SCHOOL SWIMMING SCHEME 2022**

Arrangements have been made to include a 'learn to swim' program in our school curriculum.

The Department of Education School Swimming Scheme is an intensive learn to swim program which develops water confidence and provides students with basic skills in water safety and survival. The Scheme is conducted over two weeks. Each daily lesson is 45 minutes.

Students who have not reached a satisfactory standard of water safety and survival skills, and are unable to swim 25m confidently unaided in deep water, are eligible to participate in the School Swimming Scheme. The Scheme is only for students in years 2 to 6.

Venue: Ripples, Penrith.

When: Term 4, Weeks 3 and 4. Monday 24 October – Friday 4 November 2022. The Scheme will continue daily for ten days.

Time: Depart school at 8.30am and return by 11am.

Transport: Bus

Cost: \$130. This covers the cost of pool entry and transport. There will be no charge for the lessons.

What to Bring: Students should wear their swimmers underneath their school uniform. They should have a swimming bag (separate to their school bag) which includes a towel, underwear, rash shirt, hairbrush, a piece of fruit, goggles and swim cap (if required).

Parents are advised that all teachers have been trained in Emergency Care Procedures and have CPR Training. All students with asthma will be required to keep their puffers with them and should be aware of their asthma plan. All anaphylactic and diabetic students will be required to carry their medical bag on them at all times.

As there are limited places, we will only be able to allow the first 60 children who present with their money and permission note. **There will be no POP (online) payments available for this excursion.** 

## \*Please hand your money and note to the office staff as they will be numbering them as they arrive

The last date for payment is Monday 17 October 2022. Due to a new system that the Department of Education has put in place, we cannot accept any payments after this date.

Due to banking security, payments can only be accepted between 8.30am and 9.30am weekdays. No cash will be kept on the premises. All notes and payments MUST be received by 9.30am.
